PUBLICATIONS

Prof. Deirdre Bowen's article, written along with her UW colleagues, *Implicit racial and gender bias about handguns: a new Implicit Association Test*, was accepted for publication in the *Journal of Interpersonal Violence*.

Prof. Deirdre Bowen's article, written along with her UW colleagues, *Black Women & Gun Ownership in America*, was accepted for publication in the journal, *Violence & Gender*.

Prof. Deirdre Bowen's article, *Brilliant Disguise: An Empirical Analysis of a Social Experiment Banning Affirmative Action*, 85 Ind. L.J. 1197 (2010) has been cited in AERA's *amicus* brief to the Supreme Court in two related cases, *Students for Fair Admissions, Inc., v. President & Fellows of Harvard College*, and *Students for Fair Admissions, Inc., v. University of North Carolina et al.*

Prof. Richard Delgado had an article accepted in *Case Western Law Review* analyzing immigration policy in light of Derrick Bell's theory of interest convergence.

A special issue of the *Transnational Legal Theory Journal* was published based on a conference Assoc. Dean **Sital Kalantry** co-organized on Transnational Legal Feminism. Sital co-authored the introduction to the [journal](#) and also co-authored an article in the journal entitled, "Transnational legal feminist approaches to the honour crimes provision in the Istanbul Convention," which was published in August 2022.

Melissa Lee and **Jessica Levin**, co-assistant directors of the Korematsu Center, with the 2022 Calhoun Fellows, submitted an *amicus* brief to the Washington Supreme Court in *State v. Rivers* in late July. Mr. Rivers asks the Court to ensure that people accused of crimes have an effective way, under our state constitution, to challenge a jury venire that is not representative of a fair cross section of their community. The *amicus* brief explains that an effective remedial approach to fair cross section claims under our state constitution (1) will help counteract our country's racist history of excluding Black people from jury service; (2) is a principled development of this Court's anti-discrimination jurisprudence that accounts for the operation of systemic racism; and (3) recognizes important empirical evidence that diverse juries engage in a more thorough—and more fair—deliberative process. Our partners at King County of Department of Public Defense and Public Defender Association joined the Korematsu Center as *amici*.

Task Force 2.0 gave its final presentation to the Washington Supreme Court on July 13, 2022, during which the Juvenile Justice Subcommittee presented its findings and recommendations, followed by the Recommendations Working Group presenting its recommendations. **Melissa Lee** co-chaired the Recommendations Working Group and was a member of the Oversight Working Group, and **Jessica Levin** chaired the Juvenile Justice Subcommittee. Prof. Gillian Dutton's proposal entitled *Virtual Collaborations for Social Justice Across Culture and Language; Tools for the Next Generation*, to the Global Alliance for Justice Education was accepted for the December 2022 conference in South Africa. She is hoping that my colleagues (including Professor Ron Slye) on the Department of State Grant administered by the Aspen Institute will join me (and some student alums) either virtually or in person to present on our innovative class with its service project that includes Moroccan students interviewing participants in their successful Truth Justice and Reconciliation Process and American students interviewing black and brown survivors of police officer killings.

Prof. Russell Powell's book review of *Religious Parties and the Politics of Civil Liberties*, by Vineeta Yadav, was published by Oxford University Press last month in the *Journal of Church and State*.

Prof. Maggie Chon participated in the Intellectual Property Scholars Conference 2022 at Stanford Law School. She presented "Abuse of Copyright: Interventions into Racial Inequity?," a joint project with Olufunmilayo Arewa.

Assoc. Dean Steven Bender presented as the opening law faculty speaker in the Michael Olivas Memorial Writing Institute program on July 21. Prof. Deirdre Bowen appeared on Fox 13 TV show, The Spotlight, to discuss the impact of the newly expanded legal definition of domestic violence.

Hon. Janet Chung, who taught in the Legal Writing program from 2002-07, was sworn in to the Washington Court of Appeals, Division I. Dir. Mimi Samuel was asked to be one of the speakers and to focus on her connections with SU, which are many.

Prof. and Vice-Dean Designate Brooke D. Coleman has been named the Fredric C. Tausend Professor of Law.

Prof. Richard Delgado was featured in the Top 10 most cited law scholars ranking in Google Scholar, and the #1 scholar of color on the list.

Prof. Chryssa Deliganis is one of 115 legal scholars (of Professional Responsibility) who signed an *amicus* brief filed in Florida yesterday in support of the Hillsborough County Prosecutor suspended by Gov. DeSantis for exercising his First Amendment right to free speech. Prosecutor Andrew Warren had espoused views disfavoring the enforcement of abortion bans and (proposed) laws targeting transgender Floridians, positions well within his discretion as a Prosecutor. Prof. Russell Powell and **Dean Tony Varona** participated in **Seattle University's 13th Annual Berle Symposium**, held

this year at McGill University, and chaired by Prof. Chuck O'Kelley.

Prof. Gillian Dutton and Ron Slye, (along with SU alums Teri Rogers Kemp and Courtney Erwin, and professors at Moulay Ismail University in Morocco) have received a (DEIA) Diversity Equity Inclusion and Access supplement of almost \$10,000 to their Steven's Initiative Transitional Justice Legal Exchange grant administered by the Aspen Institute. Their 14-week virtual course includes law students in both Morocco and the United States and examines the role of transformative justice in Morocco and the application of transformative justice principles to U.S. criminal justice reform. Students interview survivors in both Morocco and the US and do research on how transformative justice might provide ideas for reform efforts in Washington State. The additional funding covers payment to Black Community Lobby guest speakers, interpretation of additional student meetings, and translation of student professional bios (into English and Arabic) as well as interview reports of both Moroccan and American individuals. This supplement will enable some accounts of the Moroccan truth, justice, and reconciliation process to be available in English for the first time. This may also be the first time a law school course is taught in both Arabic and English, with goals of addressing racial justice and developing student professional relationships for global practice.

Dean Tony Varona was appointed by WA Chief Justice González as Co-Chair to the Washington Supreme Court's Attorney Licensure Task Force, partnering with Co-Chair Justice Raquel Montoya-Lewis.
