#### **PUBLICATIONS**

**Prof. Michael Blasie's** next article, *Regulating Plain Language*, was accepted by the Wisconsin Law Review. The Article reveals all three branches of government have been aggressively regulating plain language in legal documents with no coordination, resulting in a nationwide hodgepodge of conflicting laws that take wildly different approaches in scope, coverage, and enforcement. The Article contends these laws embody different public policy approaches to plain language and argues for a greater role in developing plain language legal requirements through common law rules.

**Prof. Leonard Feldman's** *Tort and Accident Law: Cases and Materials* (Fifth Edition 2023), is now scheduled for publication in mid-2023. The author agreement with West Academic Publishing has been signed with co-editors Lewis Sargentich (Harvard Law School), Gregory Keating (USC Law School), and Jim Fleming (Boston University Law School).

**Prof. Jack Kirkwood** was quoted by *The Capitol Forum* in an article on "Collusion Out Loud" in the fertilizer industry.

**Prof. Russell Powell's** article "Spirit of the Corporation" was published along with a follow-on essay "A Brief Reflection on Spirit of the Corporation" in the most recent issue of the Seattle Law Review as part of the Twelfth Annual Berle Symposium: Corporate Capitalism and the City of God.

#### **PRESENTATIONS**

**Assoc. Dean Steven Bender** presented at the SALT teaching conference in Chicago as part of a plenary teach-in panel that he helped plan on the current affirmative action cases before the Supreme Court. This was a prelude to a fall 2023 symposium to be held at Seattle University based on the 25<sup>th</sup> anniversary of the SALT affirmative action march, as academic activism, at the AALS annual meeting in San Francisco.

**Assoc. Dean Steven Bender** co-presented a Zoom workshop to dozens of law faculty across the country on using the Critical Justice textbook as an institutional framework for a robust compliance response to ABA Standard 303. **Assoc. Dean Steven Bender** co-presented with a Canadian law professor on their book series with Rowman & Littlefield Press, called Migration, Development, and Displacement. They presented via Zoom to an audience of students and faculty at Lebanese American University, home to one of the book series' many Editorial Board faculty across the world.

**Prof. Michael Blasie** presented *The Doctrine of Plain Language* on October 8 at the 10th Annual Western Regional Legal Writing Conference held at the University of Oregon's law school. During the presentation, he argued legal writing is highly regulated by nearly 800 overlapping and conflicting statutes, regulations, and constitutions that balance competing public policy considerations. He posited there is a sizeable unexplored doctrinal realm to legal writing and encouraged an aggressive expansion of legal writing scholarship.

**Prof. Michael Blasie** also presented *A Common Law Duty to Make Contracts Understandable* at the Midwest Law and Economics Association's annual conference, hosted at the University of Chicago on October 14. Professor Blasie presented alongside professors from the laws school at the University of

Chicago, University of Houston, University of Oklahoma, and University of Iowa. His presentation argued courts should impose on drafters of contracts of adhesion a duty to make their contracts understandable to the average intended reader.

**Prof. Katy Boling** presented *People-Centered Legal Teaching: Centering Students' Understanding of the Law around the People Who Make and Apply it on October 8 at the 10<sup>th</sup> Annual Western Regional Legal Writing Conference held at the University of Oregon's law school.*

**Assoc. Dean Steven Bender** prepared, gathered signatures, and submitted a proposal to the AALS Executive Committee for a new section to be called the Critical Scholarship, Pedagogy, and Literacy Section. He will serve as the Initial Section Chair if the section is approved.

**Prof. Richard Delgado** will be celebrated for his former work in the Texas Institute for Advanced Study (Hagler Institute). This will be published in the anniversary issue of the Texas A&M Law Review. Richard Delgado's commentator will be Frank Michelman (Harvard) writing about Delgado's work on a criminal defense of extreme poverty, which Delgado developed in two law review articles on the "Rotten Social Background' defense. **Research Prof. Margaret Fisher** has successfully written three grants this fall: the U.S. District Court for Western Washington funding for the 2022-23 Judicial Institute for Teachers, now in its 11th year; the Washington Judges Foundation funding to continue Street Law for judge-teacher teams, now in its 21st year; and the Washington Judges Foundation support for the 2022-23 youth court statewide conference now in its 18th year.

**Prof. Elizabeth Ford's** article, *Wage Recovery Funds*, has been selected as the topic for an upcoming <u>California Law Review's podcast</u>. More details to come!

**Prof. Elizabeth Ford** also was appointed by Governor Inslee to serve as one of three commissioners on the Public Employment Relations Commission. They regulate public sector collective bargaining in Washington.

**Assistant Dean Erin Fullner** was appointed to the Washington Bar Association Small Town and Rural Practice (STAR) Committee.

**Civil Rights Clinic faculty Jessica Levin and Melissa Lee** filed two amicus briefs before the Washington Supreme Court. The first case, *State v. JWM*, involves the imposition of a lengthy period of

incarceration on a young person of color based on purported treatment needs as well as criminal history. The amicus brief discusses literature regarding adultification of Black youth and other youth of color and asks the Court to direct juvenile courts to account for adultification bias in their disposition decisions. The brief also educated the Court about the harms of incarcerating young people and requested that the harms of incarceration be considered as a non-statutory mitigating factor in any case where a period of incarceration is requested. CRC faculty partnered with King County of Public Defense and TeamChild on the brief, and represented CHOOSE180 and Creative Justice as amici. The second case, *State v. Anderson*, involves the imposition of a de facto life sentence for a crime Mr. Anderson committed as a child. Mr. Anderson moved for reconsideration of the Court's decision upholding the de facto life sentence; CRC faculty filed an amicus motion in support of reconsideration explaining how the Court's articulation of the state constitutional inquiry improperly narrows what must be considered under *Miller v. Alabama* and other Eighth Amendment jurisprudence. CRC faculty were joined on the brief by Juvenile Law Center and represented Huy as amicus.

**Assistant Dir. Melissa Lee** served as co-chair of the Recommendations Working Group of the Task Force on Race and Washington's Criminal Justice System 2.0 where they issued their final recommendations regarding the adult criminal legal system on October 10. In that role, Assistant Dir. Lee was responsible for coordinating the generation of recommendations from diverse criminal legal system stakeholders, as well as compiling and drafting the final recommendations for publication. View the press release.

**Assistant Dir. Melissa Lee** was featured in a report on KIRO News Radio's Seattle's Morning News show on October 13 discussing the recommendations for reforms in the criminal legal system issued by Task Force 2.0.

Assistant Dir. Jessica Levin was interviewed for the Northwest Politicast Podcast regarding *State v. Rivers*, a case argued in September 2022 before the Washington Supreme Court concerning lack of diversity in jury pools. Mr. River's proposed state constitutional rule would provide an effective remedy to people accused of crimes who are seeking to vindicate their right to select a jury from a fair cross section of their community.
