The journal's invitation letter cites his "outstanding record of accomplishment and significance to Critical Race Theory scholarship (that) has reshaped how legal scholars understand civil rights law, race jurisprudence, and whiteness studies." The journal will invite eight scholars to comment on his work. Also, *Michigan Law Review* accepted his proposal to review Amy Greenberg's *A Wicked War: Polk, Clay, Lincoln, and the 1846 Invasion of Mexico* for its annual review of books related to law.

**Jack Kirkwood's** article, *The Essence of Antitrust: Protecting Consumers and Small Suppliers from Anticompetitive Conduct,* has been published by the *Fordham Law Review*. The article is one of fourteen articles in a symposium on The Goals of Antitrust that Jack helped organize.

**Mary Bowman** completed her service as Chair of the Program Committee for the AALS Section on Legal Writing, Reasoning and Research and continued her work as Chair of the Scribes Law-Review Award Committee.

**The Center for Global Justice** inducted six new Student Fellows: Yasmin Christopher , Whitney Knox, Lizamarie Mohammad, Alison Pastor, Holly Scott and Alison Wright. The Center for Global Justice has joined SU's Center for Environmental Justice and Sustainability, Center for the Study of Justice in Society, and Wismer Center for Gender Justice and Diversity to co-sponsor *Circle of Inquiry*, a project to facilitate collaborative and interdisciplinary inquiry and research by SU faculty. The first theme the project has taken up is "the interrelated moral challenges of climate change, ecological degradation, and social justice." Twenty-nine faculty members from different schools and departments of SU are participating in this project.

**Ronald Clark**, on behalf of the Justice Department and Organization for Security and Co-operation in Europe, trained judges and prosecutors in Sarajevo, Bosnia. The attending prosecutors and judges will train prosecutors of war crimes.

On April 2, **Eric Eberhard** was the lead witness for a workshop held by the Committee on Community Development, Housing and Tribal Affairs of the Washington State House of Representatives to review issues involved in business and economic development on the 29 Indian reservations in the state. Eric's testimony was well received by the committee and elicited follow-up questions from every member of the committee. **Madeline Kass** is participating in a university-wide, interdisciplinary academic project co-sponsored by Seattle University's Center for the Study of Justice in Society, the Wismer Center, the School of Law's Center for Global Justice, and the Center for Environmental Justice and Sustainability. The program, *Circles of Inquiry*, examines the interrelated moral challenges of climate change, ecological degradation, and social injustice.

**Denis Stearns** has signed a contract to author two entries in FOOD ISSUES: AN ENCYCLOPEDIA, a multivolume inter-disciplinary referencework being edited by Ken Albala, Ph.D, and to be published in 2014 by Sage Publications. The entries will be entitled, *E. coli O157:H7: A Multifaceted History*, and *Food*, *Torts*, *and Civil Litigation*.
