# The Japanese American Incarceration: Civil Liberties & Upholding the Rule of Law, Then and Now

During World War II, 120,000 persons of Japanese ancestry were removed from their West Coast homes and incarcerated in desolate camps in the interior U.S. Twothirds were American citizens. They had committed no crimes; they were incarcerated simply because of their race. Please join us for an important discussion of the infamous Supreme Court cases that upheld that incarceration, the coram nobis cases that successfully reopened them, and their haunting present-day relevance.

Distinguished speakers include Karen Korematsu, daughter of Fred Korematsu, who challenged the wartime orders in Korematsu v. United States, and Judge Marilyn Hall Patel, who vacated Mr. Korematsu's conviction.
