The Moderate Means Program (MMP) is an ATJI Partnership Project run in collaboration with the Washington State Bar Association and the two other law schools in Washington State. Seattle University was the first law school to implement the program in the Spring of 2011. The purpose of the program is to increase access to civil legal services for moderate means individuals (those between 200% and 400% of the federal poverty level) who cannot afford to hire private attorneys at market rates but make too much money to qualify for traditional civil legal aid services. Through this program, eligible clients can get assistance in the areas of Family, Consumer and Housing law.

# The Japanese American Incarceration: Civil Liberties & Upholding the Rule of Law, Then and Now

During World War II, 120,000 persons of Japanese ancestry were removed from their West Coast homes and incarcerated in desolate camps in the interior U.S. Two-thirds were American citizens. They had committed no crimes; they were incarcerated simply because of their race. Please join us for an important discussion of the infamous Supreme Court cases that upheld that incarceration, the coram nobis cases that successfully reopened them, and their haunting present-day relevance.

Distinguished speakers include Karen Korematsu, daughter of Fred Korematsu, who challenged the wartime orders in Korematsu v. United States, and Judge Marilyn Hall Patel, who vacated Mr. Korematsu's conviction.

### Firearm Surrender Program: Protecting Domestic Violence Victims

Future Prosecutors for Social Justice will host a panel of speakers involved in the City of Seattle and King County's Firearm Surrender Program. The panel will discuss how the program has helped protect abuse survivors and the public.

Abusers accused of domestic violence are often ordered by the court to surrender their firearms. However, of the abusers who receive a court order to surrender their firearms, more than half ignore the order. Additionally, out of the very small number of abusers who do respond, very few actually give up their guns.

The City of Seattle and King County, along with efforts from the Seattle Police Department, are working to follow-up with these surrender orders and ensure compliance by the accused abuser. In May 2017, the Seattle City Council approved legislation to dedicate funding to enforce a state law that required domestic abusers to surrender their firearms.
