On July 28, 2019, the law in Washington State was amended to expand eligibility for vacating criminal convictions in Washington State. This amendment is called the New Hope Act. This new law not only streamlines the process for vacating a criminal conviction but also conforms the rules and procedure for vacating misdemeanor with vacating felonies.
