Restoration of Inherent Tribal Criminal Authority over Non-Indians through The Violence Against Women Act

In celebration of Indigenous Peoples' Day, come and learn about tribal court enforcement of the Violence Against Women Act (VAWA) from Philip Tinker and Katie Jones, attorneys at Kanji & Katzen, a nationally recognized firm that represent tribes in high stakes litigation. Tribal governments possess inherent sovereign

authority over their members and territories, but federal law places significant restrictions on the exercise of that authority over non-Indians. Those restrictions can severely hinder the ability of tribal governments to keep their citizens and communities safe. One of the most severe effects is with respect to violence against Indian women: Native women are the highest targeted demographic of domestic violence and sexual assault in the United States, and the vast majority of the perpetrators of this violence are non-Indian men. Please join us to learn more about how advocates are working to ensure VAWA and other legal securities remain intact for the protection of Tribal communities and Tribal sovereignty.

OPPORTUNITY TO OBSERVE WORKERS' COMPENSATION HEARING AT THE LAW SCHOOL

October 21 | Call to order at 9:00am | Sullivan Hall Courtroom

On Monday, October 21, Judge Evan Nordby of the U.S. Department of Labor, Office of Administrative Law Judges, will hear a Longshore Act workers' compensation case in the Dore Courtroom (Room 105). Judge Nordby will call the hearing to order at 9:00 a.m.

The Longshore and Harbor Workers' Compensation Act is a federal law that provides for the payment of compensation, medical care, and vocational rehabilitation services to employees disabled from on-the-job injuries that occur on the navigable waters of the United States, or in adjoining areas customarily used in the loading, unloading, repairing, or building of a vessel. These benefits are paid by a private insurance company on the employer's behalf, or by the employer if it is self-insured.

Longshore Act hearings are public, adversarial hearings tried to a judge alone, and are governed by relaxed rules of evidence. They typically feature both lay witness testimony, and, expert testimony by medical and vocational experts. Both sides are typically represented by experienced counsel. This is an opportunity to see experienced attorneys give opening arguments and conduct direct and cross examination.

From 12pm-1pm, the hearing will recess for lunch, and Judge Nordby - a former adjunct professor at the Law School and an attorney with the USDOL Solicitor's Office - will host a brown-bag lunch Q&A covering working as a federal agency litigator, labor and administrative law, the OALJ, the Mariners, and any related topics. _
