#### Other news

Tom Antkowiak's new article, "Rights, Resources, and Rhetoric: Indigenous Peoples and the Inter-American Court," published in February, has placed on four top-ten SSRN lists concerning international law or indigenous peoples. It also was featured in International Justice in the News, a monthly publication by the International Center for Ethics, Justice and Public Life of Brandeis University. The article will be reprinted in an upcoming book on indigenous rights in international law (Lapland University Press, Finland).
