

**Diane Lourdes Dick** and Keith Trefry of Paine Hamblen LLP led a session on legal opinions in real estate financing transactions at the WSBA Real Property, Probate and Trust Midyear Meeting. Professor Dick also published a guest post on the Harvard Bankruptcy Roundtable blog.

**Margaret Fisher's** Judges in the Classroom/Street Law program was selected for the 2014 Colleen Willoughby Youth Civic Education Award presented by the Seattle CityClub, given to five organizations. Her Seattle Youth Traffic Court won this award in 2012.

**Jack Kirkwood** signed on to an amicus brief of antitrust scholars in North Carolina State Board of Dental Examiners v. FTC, a Supreme Court case that addresses whether a state board composed of financially interested members of a profession can take actions that restrict competition without state supervision.

Sara Rankin was cited as an authority on homeless rights by actress Susan Sarandon in a Congressional briefing concerning whether the homeless should be added to hate crime legislation on June 26. She is also the main organizer and one of two key facilitators of the first Statewide Conversation on Homeless Rights. This meeting will be held on Friday, September 26, 2014 at Seattle University's Student Center Room 210 from 12 p.m. to 2 p.m. This first conversation will focus, in particular, on the criminalization of homelessness across Washington and on efforts to collect data to combat such criminalization. Professor Rankin has also submitted a proposal to the IRB for her students to participate in a nationwide survey administered to homeless men and women. The study is one part of a broader policy advocacy effort to stem the criminalization of homelessness in the United States.

The 13th National IDEA Academy for Administrative Law Judges and Impartial Hearing Officers was hosted by the Law School under the direction of **Jim Rosenfeld**. Nearly 70 special education hearing officers from 14 states attended the four-day training, covering topics from assessment of children with disabilities – presented by national expert Jerome M. Sattler, Ph.D. – to the neuroscience of decision-making – presented by Kimberly Papillon, Ph.D. Mimi Samuel and Laurel Oates organized and hosted a 5-day CLE for U.S. attorneys in Johannesburg, South Africa at the end of May. In addition to attending daily lectures by professors at Wits University orlocal practitioners, the CLE participants went on daily field trips to local law firms, courts, and cultural institutions. Highlights of the week including visits to the South Africa Constitutional Court and the Johannesburg Magistrates Court; the Apartheid Museumand the Mens and Womens Prison museum; and Section 27, a non-profit focusing on legal issues relating to health, housing and education. The participants also had the opportunity to sit in on intake interviews at the University of Witwatersrand Immigration Law Clinic. Finally, participants went to a local theatre production and went on a "shebeen" tour of Soweto.
