## Other News

**Robert Boruchowitz** testified at the U.S. Senate Judiciary Committee hearing on “Protecting the Constitutional Right to Counsel for Indigents Charged with Misdemeanors.” He told the Committee that misdemeanor

public defense in much of the country is broken and in many places it hardly exists and recommended targeted federal funding, legislation to authorize the Justice Department to bring civil actions to remedy patterns or practices by local government that deprive persons of their right to counsel, and the establishment of a National Center for the Right to Counsel. **Robert Chang**, working with local counsel from Dorsey & Whitney's Anchorage office, and with a pending motion for admission *pro hac vice*, submitted an amicus memorandum on behalf of the Korematsu Center and the Center for Indian Law & Policy in a case before the Superior Court for the State of Alaska, Third Judicial District at Anchorage. The plaintiffs, the Native Village of Hooper Bay and the Native Village of Kongiganak, had won a preliminary injunction to stop the state from placing tribal children in foster care in locked psychiatric hospitals without any judicial oversight. Further briefing, including from amicus groups, was invited by the judge on the issue of when a hearing was required post-admission.

**Margaret Chon** participated in a workshop for a forthcoming book on IP and Health-Related Goods, co-sponsored by NYU Law, City University London, and HEC Paris. She also gave a talk on her current project, entitled “An Economy of Scarcity (of Smart Information)” for the Intellectual Property Discussion Group at Oxford University.
