Social Justice Monday: International Refugee Assistance Project: Looking Forward to the Next Chapter of Immigration Law and Policy

The International Refugee Assistance Project (IRAP) is an international organization that provides legal advocacy for refugees and displaced people in need of a safe place to call home. IRAP works with clients from all over the world to navigate pathways to safety through free legal direct representation, systemic advocacy, and litigation. Following a brief introduction by IRAP students about the work of the SU Chapter, IRAP attorney Mary Dahdouh will discuss her experience working as an immigration attorney, as well as the harsh reality of persistent weak spots in U.S. immigration policy, and her hopes for a legal future that is more approachable and efficient for displaced clients. Ms. Dahdouh will also touch upon the importance of cross-cultural understanding in immigration work and offer insight into pursuing a successful career working with refugee and asylum-seeking clients.

Workers' Rights in the Wake of a Global Pandemic

Even before COVID-19 exploded in the United States, the worklaw system here had already created levels of wealth and income inequality not seen since the great depression, systematically divesting Black, native, immigrant and other vulnerable communities of wealth and income. The COVID-19 pandemic has magnified these inequities and enhanced the need for a conversation to both expose the underlying structures and to offer paths forward to a healthier future. This symposium aims to create space for that conversation among academics, practitioners, and community advocates to analyze the ways in which the COVID-19 outbreak has impacted safeguards for workers.
