# Social Justice Monday: The Immigration System and Reform in a New Era

Linda Dakin-Grimm, a longtime litigation partner at Milbank LLP and the author of *Dignity & Justice: Welcoming the Stranger at our Border* (Orbis Books 2020), will discuss the country's immigration crisis and how we got here, telling stories of real immigrant children and separated families she represents. # A Conversation with the Hon. Carlton W. Reeves: Making history on the federal bench

As part of our signature Influential Voices speaker series, the Hon. Carlton Reeves will join us to talk about his tenure on the U.S. District Court for the Southern District of Mississippi. Judge Reeves's notable cases include Campaign for Southern Equality v. Bryant, which held that Mississippi's ban on same-sex marriage was unconstitutional; Jamison v. McClendon, in which Reeves authored a scathing critique of the qualified immunity doctrine; and US v. Butler, in which Reeves spoke powerfully on the legacy of lynchings in Mississippi in the course of sentencing three men for their roles in the racist murder of James Anderson.

The Hon. Marsha Pechman, U.S. District Court judge for the Western District of Washington, will introduce Judge Reeves. Professor Natasha Martin, Seattle University's vice president of diversity and inclusion, will moderate the event.
