

Tom Antkowiak published a book chapter, "Social, Economic, and Cultural Rights: The Inter-American Court at a Crossroads," in *The Inter-American Court of Human Rights: Theory and Practice, Present and Future* (Intersentia Press).

Other News

Robert Chang, admitted pro hac vice representing the Korematsu Center and the Center for Indian Law & Policy (CILP), sought leave from a superior court in Anchorage, Alaska, to file an amicus memorandum in a case involving the involuntary psychiatric hospitalization of Native foster children. The Korematsu Center and CILP had previously filed an amicus memorandum in this case setting forth the statutory and constitutional basis that would require a judicial hearing within three days of admission. The new amicus memorandum is in support of the Native Village of Hooper Bay and the Native Village of Kongiganak seeking reconsideration of the judge's order requiring a hearing within 30 days of involuntary admission. Bob was also recognized in the Fall 2015 issue of the National Jurist for his work advancing diversity.
