Description: The Tulalip Tribal Court is a general civil and misdemeanor criminal court. The Judicial Clerk will draft orders, research motions, draft memorandum on discreet legal issues, participate in multi-disciplinary meetings for drafting of rules. The position may require confidential research on procedural or substantive Indian criminal justice issues.

Qualifications: 2L or 3L preferred, but 1L may be considered depending on experience. Preferred applicants have excellent writing and interpersonal skills.

Compensation: \$16.69 per hour. Full or part-time positions are available during Summer semester. Part-time (15 hrs/week) positions are available during Fall and Spring semesters.

Western District of Washington Summer Diversity Externship Program

Interested in applying for the summer Federal District Court paid externship? Join us for a virtual panel on Thursday, January 20 with Judges Tsuchida, Fricke and Vaughan. Bring your questions!

There is a national effort to provide federal judicial externship opportunities to students who are underrepresented in the legal profession. The ABA Judicial Internship Opportunity Program, the Administrative Office of the United States Courts Summer Judicial Internship Diversity Project, and the Sonia & Celina Sotomayor Judicial Internship Program are just a few examples of this ongoing effort. These efforts highlight both the importance of diversifying the judiciary and

judiciary staff, and the need to provide underrepresented law students opportunities to develop the skills and gain the experiences necessary to meet the needs of the wide range of cases and clients that come before the Courts. The Western District of Washington thus seeks to provide judicial externships to law students who are underrepresented in the legal profession and provide each student with a rigorous and structured educational program and a \$5,000 stipend to defray the students' living expenses. Externship opportunities will be in both District Judge and Magistrate Judge chambers in Seattle and Tacoma.

Eligibility Criteria

The program is open to all 1L and 2L students at an accredited law school who seek a judicial externship as part of a law school judicial externship class. Exceptions to the externship class requirement will be considered on a case-by-case basis. This is a summer externship that starts between May 31, 2022, and June 13, 2022, depending on the students' law school terms. The externship is an eight-week, full time program. The externship will be demanding, and externs should be hardworking, organized, honest, ethical, and committed to making the most of their summer to gain critical lawyering skills and habits.
