To accommodate employer demand, in-person interviews will be held

on Thursday & Friday, July 21 & 22, and virtual interviews will take place on Monday, July 25. Employers will indicate their preference for in-person or virtual interviews when they register. Last year roughly 150 employers, 190 law schools, and 1,100 law students from across the country participated in the program. Online student registration for this nationwide interview program is now open!

Registration Deadline: Monday, March 21 at 11:59 pm

Begin by reviewing participation and eligibility instructions on the webpage. This initial registration requires basic contact, school, and class year information, and includes a non-refundable \$40 dollar registration fee. The Loyola Patent Law Program staff will send a confirmation e-mail from with additional instructions once your registration is confirmed. Late registrations will not be accepted.

Student Eligibility

Students graduating in December 2022 through May 2024 may register for the Patent Law Interview Program. You do not need to be patent bar eligible to register, although the majority of employers participating in the program are seeking patent bar eligible students.
