The amount of the award is variable; in recent years, the amount has ranged from \$8,000.00 - \$15,000.00. In addition to the cash grant, the winner is—if possible—honored with recognition at the Conference luncheon attended by some 300 labor and employment attorneys. Completed application materials should be uploaded to the form contact info Redacted. The scholarship recipient(s) will be presented with the award at the 2022 Annual IP Institute in May (date TBA).
