

Other News

With Columbia Legal Services, **Bob Boruchowitz** wrote and filed an amicus brief in the Washington Court of Appeals on a case involving the failure of the Department of Corrections to provide a case-by-case determination of the right to counsel in revocation hearings. The Court of Appeals had made clear the case-by-case right to counsel determination in an opinion in a case that he argued in 2015. That case began in Bob's Right to Counsel Clinic, when they won a writ ordering the DOC to allow them to represent their client in a revocation hearing. The Washington Appellate Project asked them to write an amicus brief in the current case.

Carmen Gonzalez participated in the Latinas in the U.S. Summit, which took place at the White House. Organized by the White House Initiative on Educational Excellence for Hispanics, the summit brought together distinguished Latinas in academia and the professions to discuss challenges facing Latinas in higher education and the U.S. workforce. Also, Carmen Gonzalez' book, *International Environmental Law and the Global South* (Cambridge University Press, 2015), was favorably reviewed in the American Journal of International Law. The review is available at 110 AJIL 617 (2016).
