## AI Law Society & IP Law Society: Forensic Authorship with Professor Ainsworth

Recently two teams of linguists analyzed the writings of the self-styled Q of Qanon, to determine whether the alleged Q documents were by a single hand, and who that author might be. Both teams, though working independently, were able to establish the authorship of the initial Q writings, and then that the Q writings were later on authored by a second person, and made an identification of that author as well.

This is just an example of the importance of being able to analyze a writing and show who the author of that writing is. Legal cases often turn on this kind of analysis—the authorship of wills, ransom notes, suicide notes, criminal confessions, threatening letters, terrorist manifestos and the like are often pivotal evidence in court. But that means that we must be confident that our methods of authorship analysis really work—that we can confidently say that forensic linguists can identify who authored a document and who did not. Do we have the scientific tools today to do reliable authorship identification? Can algorithmic-based analysis find patterns in language that even expert human linguists cannot? How can we make these tools more and more precise, and how do we know that we have done so? Finally, how can forensic stylometry—algorithmically-based analysis of questioned texts—serve as a model for other forensic sciences today, and help assure that science is contributing to justice being served and not to miscarriages of justice?

#### The Culp Collection

The Culp Collection, brought to Seattle University by SU Law Professor and Korematsu Center Executive Director Robert Chang, is comprised of over 5,000 books from the personal collection of the late Prof. Jerome McCristal Culp, Jr., the first tenured professor of color at Duke Law. Reflecting Prof. Culp's own scholarly interests, the Culp Collection is broadly focused on social justice and the law and includes books on justice, equality, critical race theory, law and economics, and sexuality and gender and the law, among other topics. It is an indispensable resource for SU faculty and students researching social justice issues, and its books are frequently loaned to other law schools and universities to support

similar research at those institutions.

Prof. Culp was a prolific scholar writing on law and economics, race and the law, and sexual orientation and gender and the law. Prof. Culp also served as an expert witness on behalf of civil-rights plaintiffs in cases including Romer v. Evans which resulted in a landmark Supreme Court decision on the rights of LGBTQ people. During his lifetime, he co-authored several articles with Prof. Chang, and you can read more about their relationship and Prof. Culp's powerful voice in an article by Prof. Chang published in the Villanova Law Review.

In addition to its research value, the collection contains many books that are interesting reads in their own right. The Culp Collection is located on the first two stacks inside the entry to the Reserve Area; check it out!

- Psychiatry: services provided by referral from an on-campus medical or mental healthcare provider.

Apply today! This is a great part-time program if you are also working or taking classes during the summer. Your hours all count for the Pro Bono Pledge and you are helping reduce the justice gap!

The Moderate Means Program is one of the best ways available at SU Law to gain experience interviewing clients. Through the program you will increase your knowledge of housing, family, consumer and unemployment law, as well as professional responsibility. Participating in the program is convenient because everything is done remotely and you can arrange your MMP hours around a summer job or between classes.

The goal of the program is to increase access to civil legal services by people of moderate means who cannot afford an attorney but make too much money to qualify for traditional legal aid services. Law students serving as MMP volunteer interns will interview potential clients by telephone to collect information and evaluate their cases. Qualifying cases will be referred by the MMP interns to participating private attorneys who have agreed to represent Moderate Means Program clients for a reduced fee.

#### Benefits to students:

- 0. Hands-on experience interviewing clients;
- 1. Training in substantive legal issues, issue-spotting, interviewing skills and ethics;
- 2. Instruction on how to use the Legal Server database, which is used by most of the civil legal aid organizations in Washington State as well as the SU Law Clinics;
- 3. Flexible schedule: after the initial training you choose what your hours will be;
- 4. Supervision and mentoring by experienced attorneys;
- 5. The satisfaction of helping moderate income individuals who otherwise might not receive any legal help at all.

MMP interns will be expected to commit to a minimum of six hours a week for the duration of the summer. Training for the program will begin the week of May 16. The summer cohort will be limited to the first 15 students who apply.
