### **Law Library**

Did you know the Law Library has more than just books and databases?! In addition to our many tables, carrels, and [study rooms](#), we have a standing desk in the Reserve area and portable standing desks and bookstands you can borrow. You can also borrow phone chargers if you forget yours at home, portable DVD players, security cables to lock laptops, and whiteboard markers and erasers. There is also a scanner in the DDC you can use to scan and email yourself documents and book sections, and printers in the DDC and on the 3<sup>rd</sup> floor.

Our books and databases are great too, of course, and our librarians and staff are here to help you use it all and answer any questions!

### **Seattle Youth Traffic Court – A Restorative Justice Court**

Law mentors are needed to serve as mentors to defendants and high school volunteers. In Youth Court, high school students sentence their peers under restorative justice principles for traffic infractions committed in Seattle. The time commitment is 1-3 hours per week, on Monday afternoons at the law school or at the Seattle Municipal Court. High School students serve as attorneys, judges, court staff and jurors in determining dispositions for defendants who were ticketed by Seattle police. This is a joint project of Garfield High School, Seattle Municipal Court, Seattle Police Department, and Seattle University School of Law. Law students earn pro bono credit.
