

#### Other News

**Bob Boruchowitz**'s 2015 study on the increased costs associated with death penalty cases was cited in <u>The Seattle Times</u> editorial calling for an end to the death penalty.

**Lisa Brodoff** and Robert's Fund developed a survey of attorneys who practice in Washington State that attempts to determine the specific attitudes, behaviors, and skills that make an *opposing attorney* both a top notch, effective advocate and yet a highly civil, respected and beloved colleague. The Civility Survey was sponsored by the WSBA and sent out to bar members in May 2016. Lisa co-wrote an article with Tim Jaasko-Fischer of Robert's Fund for the WSBA NW Lawyer Journal Dec. 2016 issue that describes the results and next steps.

Robert Chang was quoted in an article in the New York Law Journal reporting on a case, *People v. Bridgeforth*, in which the Korematsu Center, joined by national advocacy and affinity bar organizations, submitted an amicus brief. See "N.Y. He also wrote in <a href="SCOTUSblog">SCOTUSblog</a> about disparaging trademarks and the pending case brought by a Portland dance band.

**Charlotte Garden** is quoted in <u>In These Times</u> about future legal challenges to fair-share fees collected by public sector unions. She also spoke with <u>BuzzFeed</u> about spending cuts at the Service Employees International Union. She's also quoted in <u>The Stranger</u>'s story about a legal challenge to Seattle's worker protection laws.

**Paul Holland** co-authored an opinion piece in <u>The Seattle Times</u> about how changing ideas about juvenile justice should cause King County to rethink its plan for a new youth detention center.

**Sara Rankin**'s work proposing a Homeless Bill of Rights is cited in this opinion piece in the Twin Cities Daily Planet.

**Anna Roberts** has accepted an invitation to present on juror bias to the Washington State Superior Court Judges' Association at their Spring Conference in Spokane.

Upon the grant of certiorari in the case of *Expressions Hair Design v*. *Schneiderman*, **David Skover** participated in the editing and signing of a merits brief of *Amici Curiae* First Amendment Scholars in support of the petitioner. Oral argument has been held in the case involving a First Amendment commercial speech challenge against a New York law that forbids merchants to declare that a surcharge is imposed on a purchase by credit card use.

**Dean Spade** is featured in this <u>AlterNet Q&A</u> about effective resistance during the Trump era. His previous opinions on whether Mayor Ed Murray can block a new youth jail are also cited in this piece by <u>The Urbanist</u>.
