Social Justice Monday: A Challenge to the Indian Child Welfare Act: Brackeen v. Haaland

The United States Supreme Court is set to hear oral arguments this year on challenges to the Indian Child Welfare Act (ICWA) in Contact Info Redacted, No. 18-11479 (5th Cir. 2021). Congress passed ICWA in 1978 in response to vast arbitrary removal of Indian children from their homes, families, and tribal communities. Now, more than 40 years since its passage, new challenges to the constitutionality of ICWA place the vital protections afforded to Indian children and families at risk. Join Tara Urs of the King County Department of Public Defense, a powerful advocate for parents in King County, as she discusses ICWA, the importance of its continued enforcement, and her work on the amicus brief filed in this case.

#### How it Works:

We welcome applicants from all over the world to network and interview for internships, entry-level and lateral positions. Candidates will visit employers' zoom rooms for conversation and interviews (via breakout rooms) throughout the afternoon. Employers will also receive a list of the registered applicants *a week before the fair*. The list includes their profile, geographic preference and a link to their resume. They may contact applicants in advance to set a time to meet at the career fair or to arrange a separate time to talk.
