

Carmen Gonzalez was the Women's History Month speaker for Earthjustice, the nation's premier public interest environmental law firm. The title of her presentation was "Women of Color in Academia and the Legal Profession: Reflections on Presumed Incompetent." The presentation was broadcast live to Earthjustice's nine regional offices.

Anna Roberts has been invited to present her research to the United States Commission on Civil Rights. She will speak on exclusion from juries of those with criminal records, and her testimony will form part of a briefing entitled "Collateral Consequences: The Crossroads of Punishment, Redemption and the Effects on Communities." This will take place in Washington D.C. in May.

Other News

Charlotte Garden spoke with The Wall Street Journal, Bloomberg, and The Seattle Times about efforts to block unionization by Uber drivers in Seattle. She also wrote an essay for The Atlantic about the future of organized labor under Trump, analyzed the U.S. Supreme Court case Water Splash v. Menon for SCOTUSblog, and spoke with Bloomberg about the \$1 per driver settlement against Uber. She also spoke with the McClatchy news service about laws protecting teen workers in the logging industry. She authored an essay for Shall Take Care about Alexander Acosta, President Trump's pick for Secretary of Labor.

Jack Kirkwood was interviewed by Public and Regulatory Reports about the Justice Department's challenge to a large hospital system's "anti-steering" provisions, which prevent health insurers from encouraging their subscribers to use lower cost providers.

David Skover edited and signed a Supreme Court brief for First Amendment amici supporting the petitioner in a commercial speech case challenging New York's restrictions on retailer's information regarding credit card surcharges. On March 3, the Supreme Court voted 9-0 in favor of the petitioner, holding that the state statute directly targeted speech and not mere conduct. The case has been remanded to the 2nd Circuit to consider the constitutionality of the law under First Amendment principles governing content-based regulations of speech.
