#### Social Justice Monday: Washington's Right to Counsel in Eviction Cases

In 2021, Washington became the first state in the nation to provide a right to counsel (RTC) for low-income tenants facing residential eviction. In Pierce County, a county with around 2,500 residential evictions each year, Tacomaprobono's Housing Justice Project is the sole RTC provider. Join us for a panel discussion on this new (and historic) RTC and learn about the realities of providing legal aid in a county with numerous evictions.
