California's Proposition 12 prohibits the sale of pork products from animals housed inconsistent with California law. In this case, the major pork trade associations have sued, arguing that the California law is unconstitutional as violating the dormant Commerce Clause. We will listen to excerpts of the oral arguments, discuss the arguments on both sides, and review what exactly the dormant Commerce Clause is about anyway.

2023 Valerie Zukin Memorial Fellowships in Immigration Law

Summer fellows gain hands-on experience advocating for immigrants in detention and enjoy close mentorship from Valerie's former colleagues and friends.

The Fellowship rotates between host organizations. Inaugural summer fellows worked at Immigrant Legal Defense (ILD) and Northwest Immigrant Rights Project (NWIRP) in 2022. In 2023, the California Collaborative for Immigrant Justice (CCIJ) and ILD will each host one Fellow for a 10-week, full-time fellowship paying \$15,000 over the course of the summer.

CCIJ utilizes coordination, advocacy, and legal services to fight for the liberation and empowerment of immigrants detained in California and their communities. To learn more about CCIJ, visit Contact Info Redacted and/or follow @ccijustice on social media platforms. CCIJ has a small office in Oakland, CA, but most work and supervision will be remote, with occasional in-person visits to detention centers and/or courts in California. Therefore, the CCIJ Fellow must reside anywhere in California during the term of the fellowship.

ILD's mission is to promote justice through the provision of legal representation to underserved immigrant communities. In her last direct services case, Valerie co-counseled a detained client with ILD attorneys at the Ninth Circuit Court of Appeals. To learn more about ILD, go to Contact Info Redacted All work and supervision for the ILD Fellow will be remote, with occasional in-person court appearances and detention center visits. The ILD Fellow can reside anywhere in the United States. Application is due on January 31 at 11:59.
