2023 LOYOLA PATENT LAW INTERVIEW PROGRAM REGISTRATION IS NOW OPEN!

In-Person Interviews - Thursday & Friday, July 20 & 21, 2023

Loyola University Chicago School of Law is hosting the Contact Info Redacted

. Interviews will be held in person on **Thursday & Friday, July 20 & 21, at the Embassy Suites Chicago – Downtown/Lakefront**. Last year roughly 150 employers, 190 law schools, and 1,300 law students from across the country participated in the program.

Registration Deadline: Monday, March 27 at 11:59 pm

Begin by reviewing participation and eligibility instructions on the Contact Info Redacted webpage. Initial registration is easy - it requires basic contact, school, and class year information. It also includes a **non-refundable \$50 dollar registration fee** to be paid by credit card. Once you have registered, the Loyola Patent Law Program staff will send confirmation directly to the email address that you entered when registering for the program. Late registrations will not be accepted.

Student Eligibility

JD Students graduating in **December 2023 through May 2025** may register for the Patent Law Interview Program. Patent bar eligibility is not required, although the vast majority of participating employers are seeking patent bar eligible students.

2023 Intellectual PropertyLawInstitute™ (IPLI™) -Application Now Open!

Admission to the program is highly competitive. Up to thirty (30) Hispanic law students are selected to participate each year from applicants across the U.S. During the week-long program, the scholars engage in robust learning experiences and connect with lawyers, judges, regulators, and legislators at the CAFC, USPTO, Copyright Office, FTC, and ITC. Scholars also receive mentoring throughout the year.

Candidates must meet the following criteria:

- A rising 2L or 3L;
- Have a demonstrated interest in intellectual property or tech law as potential practice areas; and
- Must be in good standing at an ABA accredited law school pursuing a Juris Doctor.
