MMP's purpose is to increase access to civil legal services for moderate means individuals who cannot afford to hire private attorneys at market rates but make too much money to qualify for traditional civil legal aid services. In addition to helping to bridge the justice gap, MMP provides a great opportunity for law students to gain valuable hands on experience assisting eligible clients in the areas of Family, Consumer, Unemployment Benefits, and Housing law.

There are two ways for students to get involved with the MMP:

 Fall or Spring Practicum (semester-long course) which offers 3 credits. Open to 2Ls and 3Ls.

2. Summer Internship (unpaid). Open to rising 2Ls and 3Ls (current 1Ls and 2Ls).
