### Mary Ellen Krug Award

The Mary Ellen Krug Scholarship provides funding for exceptional law students committed to the labor and employment law field. An outstanding lawyer, Ms. Krug was a pioneer in the L&E field, and envisioned a forum where all perspective would be represented. Over fifty years later, the Pacific Coast Labor & Employment Law Conference still brings together management, union, and plaintiffs' attorneys, as well as neutrals, to explore the legal challenges facing today's practitioners. The program's proceeds help fund this scholarship, which is generally awarded to a 3L who has demonstrated excellence in the field of labor and employment law, through their academic studies as well as labor/employment related activities outside of the classroom. The selection committee also considers an applicant's plans to practice in this specialty area.



## **APPLICATION INSTRUCTIONS (see attached handout)**

To apply, applicants must submit:

- **a cover letter** explaining the applicant's experience, qualifications, and reasons for interest in labor and employment law; this cover letter/personal statement may be up to five pages long;
- **your resume**;
- **an unofficial law school transcript**; and
- **two letters of recommendation** (ideally from faculty members and/or current or former employers)

All application materials (including the letters of recommendation) must be submitted to via email, **as a single PDF**, to: Matt Etter (**Contact Info Redacted**) no later than the deadline – **April 17, 2023 by 5:00 p.m**
