

Criminology Conference in Washington, D.C. Professor Adamson also was a co-panelist on "The Role of Clinical Conferences: Developing Content and Methods While Shaping our Culture" at the American University Law School Conference Critical Issues in the Development of Clinical Education: The Legacy of Elliott Milstein.

Janet Ainsworth presented the Distinguished Research Professor Lecture at China University of Political Science, entitled "Four Challenges for Multimodal Analysis of Chinese Legal Processes." She also conducted a series of workshops for graduate students at the Haidian and Changping campuses of CUPL in linguistic and legal analysis of product safety warnings and in linguistic considerations in trademark infringement cases.

**Robert Chang** presented, "Where Do Asian Americans Fit into the Conversation on Affirmative Action?" at Berkeley at a symposium, 20 Years of Prop. 209: A Conversation on the Past, Present, and Future of Affirmative Action, sponsored by the California Law Review.

**Jack Kirkwood** presented his analysis of *Apple v. Pepper*, the most important antitrust case before the Supreme Court this term, at the 10<sup>th</sup> Annual Supreme Court Watch organized by **Andy Siegel** and **Charlotte Garden**. The program was sponsored by the Seattle Historical Society.

arguments in the case, *Lamps Plus Inc. v Varela*. She was also quoted in Bloomberg Law about the Lamps Plus case and another arbitration case pending at the Supreme Court. She spoke with KNKX about the Washington Supreme Court ruling that charter schools are constitutional, expanding on the collective bargaining rights of school employees.
