On March 28th, **Tom Antkowiak** participated as a panelist at the American Society of International Law's Annual Meeting in Washington, DC. The panel was titled "Regional Human Rights Bodies as Instruments of International Law: Contradictions and Fragmentation."

On March 19th, **Lori Bannai** spoke at the Rainier Club on the wartime Japanese American incarceration through the lens of Miné Okubo's Citizen 13660. On March 20th, she spoke on the present-day relevance of the incarceration in San Diego at a showing of the film, "And Then They Came for Us," sponsored by Pax Christi.

Happily, the events were very successful, with SRO crowds. The second stage of the book tour will be held during the summer with events in Seattle, Maryland, and Delaware.
