Tom Antkowiak's two chapters, *El Principio de Legalidad y de Retroactividad* (“The Legality and Retroactivity Principles”) and *El Derecho a Indemnización* (“The Right to Compensation”) were recently published in the second edition of *La Convención Americana Sobre Derechos Humanos Comentada* (“Commentary on the American Convention on Human Rights”). The book will be distributed throughout Latin America by the Konrad-Adenauer Foundation.

Jack Kirkwood's article, “Antitrust Policy for Two-Sided Platforms: The Failure of *American Express* and the Path Forward,” received five offers of publication, including one from *Cardozo*, where it will appear. The article also ranked in SSRN’s Top-Ten download list for Monopolies.

Presentations

Janet Ainsworth's presentation entitled “Power and Pragmatics in Interactions with Police: A Berlitz Guide for Civilians in Talking to Cops” was the keynote at the University of Utah’s 3rd Annual Language and the Law Conference.

Annette Clark presented at the Clallam-Jefferson County Bar Association’s Law Day on Friday, May 3rd. The national theme for Law Day was “free speech, free press, and free society,” and she spoke on the challenges faced by institutions of higher education in holding in tension our desire to create an inclusive environment in which students feel safe and as free from harm as possible, and simultaneously one in which free expression is encouraged and valued.

On April 12, **Gillian Dutton** presented on Cultural Competence as part of a CLE entitled “Working with Interpreters and Clients: Translating Between Culture and the Courtroom” put on by the Seattle City Attorney’s office and held at Seattle University School of Law.

David Skover presented at the Tacoma-Pierce County Bar Association’s Law Day luncheon on May 3. He spoke on themes from his book, “Robotica: Speech Rights & Artificial Intelligence.”

Janet Ainsworth spoke with [KUOW](#) for a story about whether Boeing's CEO will face any personal liability for problems with the company's 737 MAX aircraft.

State v. Purcell, a Connecticut Supreme Court case decided last month rejecting the US Supreme Court rule on Miranda invocations in favor of a generous interpretation of arrestees' invocations was justified, the court said, by **Janet Ainsworth's** research showing that the narrow Supreme Court approach disadvantaged the most vulnerable groups in the population in exercising their rights.

Deirdre Bowen conducted a training on the Brain Science of Judicial Decision-making for the Superior Court Judicial Association Meeting in Spokane, WA. Deirdre was also interviewed and quoted in the [Seattle Times](#) story on the impact of the State's passage of I1000 legalizing Affirmative Action again.

Deirdre Bowen was awarded a grant from ALWD to create a LW tutorial curriculum on legal analysis.

Margaret Chon moderated a discussion with Orly Lobel on the topic "Where Competition Meets Employment & IP Law: Talent Mobility, Employee Freedom, and Social Equality" for the annual district meeting and CLE of the Western District of Washington.

Brooke Coleman, writing for [JOTWELL](#), looks at changes to the code of conduct for federal judicial officers and praises the brave work done by law clerks who have shared their #MeToo stories and made sure their perspective is included in the rulemaking process.

Gillian Dutton provided comments to the Office of Administrative Resources at the Department of Social and Health Services regarding the continuing use of DSHS Certified Interpreters and Translators. She also participated as an expert in review of the Justice Index language access criteria, part of a national survey which is conducted by the National Center for Access to Justice at Fordham Law.
