Last year over 100 employers, 165 law schools, and over 1000 law students from across the country participated in the program.

Begin by reviewing participation and eligibility instructions on the Patent Law Interview Program webpage, and then register to participate Link. Initial registration is easy - it requires basic contact, school, and class year information. It also includes a non-refundable \$50 dollar registration fee that you will need to pay by credit card. Once you have registered, the Loyola Patent Law Program staff will send confirmation directly to the email address that you entered when registering for the program. Late registrations will not be accepted.
