

Publications

Steve Bender's 2019 LatCrit symposium afterword article titled, *Collective Knowledge Production Toward Transformative Social Change: A Community-Grounded Model*, was published in the Harvard Latinx Law Review, December 2020. He additionally helped arrange and edit the proceedings of the 2020 Innovating the Built Environment symposium for The Seattle Journal of Technology, Environmental & Law, published online.

Ron Clark obtained a book contract from Full Court Press, the publishing arm of Fastcase, for his latest book entitled *Roadways to Justice: Reforming the Criminal Justice System*. In the wake of the death of George Floyd and the Black Lives Matter protests against police violence and racial injustice, the question on people's minds is whether it is possible to make lasting changes to the criminal justice system.
