prosecutors in the King County Courthouse strove to do justice, end public corruption, and reform the criminal justice system. The book argues that the criminal justice system can be changed, and it offers inspiration, practical solutions, and roadmaps for how to reform that system. This volume is ideal for anyone interested in understanding how the criminal justice system really works, and it is an indispensable handbook for the new wave of lawyers, lawmakers, and others who want to improve it. The book features Seattle University Law School and members of its faculty, especially Dave Boerner who led the way to reform the system.

**Madeline June Kass** will have her chapter, "Climate, Sustainability, and Waste – European Union & United States Regulatory Approaches Compared," published in Interdisciplinary Approaches to Climate Change. The book will be used as a textbook for the Interdisciplinary Approaches to Climate Change (IACC) Master's Program at the Universita Degli Studi Di Milano in Italy.
