Carolina Academic Press for publication of the third edition of *The Death of Discourse*. This year marks the twenty-fifth anniversary of the work, which was the first of the ten books that they have written together.

Presentations

Amanda Elyse presented "Why Legal Writing Professors Should Teach Singular 'They' Pronouns and Other Gender-Inclusive Language -- and How to Do So" at the 2021 Association of Legal Writing Directors Biennial Conference and the Carolinas Colloquium 2021.

Leonard Feldman presented to the King County Bar Association Appellate Practice Section: "How to Write, Edit, and Review Persuasive Briefs: Seven Guidelines from One Judge and Two Lawyers."

Sital Kalantry is a featured Guest Speaker in the Global Law and Business podcast by the law firm Harris Bricken.

Mimi Samuel presented a lecture on Introduction to Legal Research and Legal Writing to incoming LLB and LLM students at Symbiosis Law School in Pune, India, as part of their orientation program.

Other News

Bob Boruchowitz filed an amicus memorandum in the Washington Supreme Court in In re Ayerst, arguing that the Court should accept the case and the conviction should be reversed because the appointed public defense counsel was not admitted to practice law in Washington.

Robert Chang, on Aug. 30, 2021, argued in Superior Court in Anchorage, Alaska, on behalf of plaintiffs, the Native Village of Hooper Bay and the Native Village of Kongiganak, a motion for summary judgment and permanent injunction in a case involving due process rights of Alaska Native foster children committed to a private psychiatric hospital. Additionally, he and David Perez of Perkins Coie, are the recipients of the 2021 Kathleen Taylor Civil Libertarian Award from the ACLU of Washington for their work seeking to protect people protesting following the killing of George Floyd. Working with a team of attorneys from Perkins Coie, ACLU-WA, and the Korematsu Center, they secured a TRO and later won a contempt motion. So far, there have been three published decisions: TRO Order, 466 F. Supp. 3d 1206 (W.D. Wash. 2020) (TRO Order); 505 F. Supp. 3d 1108 (W.D. Wash. 2020) (finding of contempt); 516 F. Supp. 3d 1202 (W.D. Wash. 2021) (sanctions). Furthermore, he was quoted in a few articles regarding the Arizona Supreme Court's Order eliminating peremptory challenges in jury selection in "Arizona Supreme Court First State to end peremptory challenges to potential jurors", "Arizona eliminates peremptory challenges in jury selection", and "Arizona breaks new ground in nixing peremptory challenges". The Korematsu Center has been active addressing discrimination in jury selection since 2016 in court filings in NY, NC, LA, TN, and WA.

Annette Clark has been selected by the Washington Women Lawyers (WWL) to receive the 2021 Chief Justice Mary Fairhurst Passing the Torch Award, which is awarded to an individual each year who has gone above and beyond in mentoring women lawyers, making a difference, and "passing the torch" to others in a way that supports the

WWL Mission Statement. She will receive the award at WWL's Annual Event on Oct. 16.

Margaret Fisher has been invited by Street Law Inc. to participate in the year-long Street Law International Collaboration Project, funded by the Eurasian Foundation. The Seattle Youth Traffic Court will be partnered with a Eurasian law school in October 2021. Law students from the two countries will devise and present social justice issue lessons of relevance in both countries throughout 2021-22. Margaret and one law student will attend the concluding program in Tbilisi, Georgia in May 2022.
