About the Authors

FRANK D. LOMONTE

Frank LoMonte is a professor at the University of Florida, where he teaches media law and runs the Brechner Center for Freedom of Information, a think-tank dedicated to producing practical research about the law of access to civically essential information. At the Brechner Center, he serves as publisher of *The Journal of Civic Information*, a quarterly peer-reviewed journal of practical scholarship, and as executive producer of “Why Don’t We Know,” a podcast focusing on secrecy in government. He previously worked for nine years as executive director of the Student Press Law Center in Washington, D.C., practiced law with Sutherland LLP in Atlanta, and clerked for federal judges on the Eleventh Circuit U.S. Court of Appeals and the Northern District of Georgia.

Dimitrios Kafteranis is a Ph.D. candidate at the Research Unit in Law at the University of Luxembourg. Dimitrios obtained a Bachelor’s degree in English Language and Literature and Law. He holds a Master’s in European and International studies and an LL.M. in European Economic and Financial Criminal Law. His thesis focuses on the protection of whistle-blowers in the EU banking and financial sector. Dominique has served on the King County Juvenile Justice Equity Steering Committee, where he worked with Superior Court judges to address racial inequity in the juvenile justice system, the Budget for Justice coalition making recommendations in Seattle’s City budget for investments in effective community alternatives to incarceration, and the Washington State Criminal Justice Training Commission to create guidelines to establish law enforcement training requirements and criteria for independent investigations of deadly force.

Dominique has previously served as Co-Director of the Choose180 Program, a misdemeanor diversion program, which was named 2015 Best New Nonprofit by Seattle Foundation and Seattle Met Magazine under his leadership. Dominique received the NW Justice Forum’s 2017 Restorative Justice Award and was named one of the Most Influential Seattleites of 2017 by Seattle Magazine. He also enjoys being a coach and personal trainer in the community.

MARIE GOTTSCHALK

Marie Gottschalk is the Edmund J. Kahn Distinguished Professor at the University of Pennsylvania, where she specializes in American politics. She is a leading expert on the carceral state and served on the National Academy of Sciences Committee on the Causes and Consequences of High Rates of Incarceration.
